We're writing to alert you to a new threat has quietly found its way on to the May ballot. It seems harmless, yet when you understand the consequences, you'll agree, it's a very bad idea!

It's called Measure 24-292. If passed, it would expand the Marion County commission from three persons to five. Again, it sounds harmless ... three commissioners, five commissioners; does it really matter? Actually, it does. Especially the way this measure was written. Here are just a few examples:

- **Measure 24-292 will add over \$500,000 in cost.** The estimated cost to expand from three commissioners to five is over \$500,000 this year alone. The added cost goes to salaries, staffing, new offices and to fund a special election.
- **Measure 24-292 could force additional cuts in public safety.** The Marion County Sheriff's Office has already had to cut its budget by as many as 15 full time positions because of shrinking tax revenues and a down economy. In order to fund the added \$500,000 in expenses to support two new county commissioners, public safety will surely take another big hit. This could include additional reductions in patrol units which would decrease response time throughout the county, cutbacks in the DA's office and even reduce prison space.
- **Measure 24-292 would allow secret government meetings.** Oddly, Measure 24-292 would allow commissioners to hold secret and private meetings, two by two, out of the public eye. This provision alone is enough to demand Measure 24-292's defeat. With confidence in government at an all time low, the last thing we need is a law that actually protects secrecy and back room deals.
- **Measure 24-292 would greatly limit your voice in local government.** If Measure 24-292 passes this May, the commissioners will be elected by regions within the county. That means you and I as voters will choose only one of the county commissioners making critical county decisions, rather than all of them as we do today. In other words, you will have no say in the election of four out of five of these important decision makers. If they raise fees, spend money unwisely or make other poor decisions, we have no way to hold them accountable.


